I hereby agree that I, my heirs, distributees, guardians, legal representatives and assigns, will not make claim against, sue, attach the property of, or prosecute the City of Huntington Park and/or the Huntington Park Department of Parks & Recreation and its employees, officers, officials, volunteers, boards, departments, agents and contractors for emotional distress, bodily injury or death to myself or property damage arising out of any actions, by any employees, officers, officials, volunteers, boards, departments, agents and contractors in connection with my participation in this activity. In addition, I hereby release and discharge the City of Huntington Park and its employees, officers, officials, volunteers, boards, departments, agents and contractors from all actions, claims and demands I, my heirs, distributees, guardians, legal representatives or assigns now have or, may hereafter have, for emotional distress, bodily injury or death to myself, or property damage resulting from my participation in this activity. In case of accident or other emergency, personnel of the City of Huntington Park/Department of Parks and Recreation and/or its agents, are hereby authorized to secure medical care deemed necessary as a result of accident or injury, for the participant. I further agree to pay any and all costs incurred as a result of this treatment. I further permit the use of activity/event photography and/or video taping for promotional use/ or the City of Huntington Park website.

**Code of Conduct:**

ANY INFRACTION OF THE FOLLOWING RULES OF CONDUCT WILL RESULT IN THE IMMEDIATE DISQUALIFICATION OF THE PLAYERS, PLAY OR TEAM INVOLVED. NO PLAYER SHALL appear on the field of play, or in gym, at any time in an intoxicated condition. PENALTY: suspension from season and if violation occurs again, suspension from all league play in Huntington Park & Recreation Department. NO PLAYER SHALL at any time lay a hand upon, push, shove, strike, or threaten to strike an official. NO PLAYER SHALL use profane, obscene or vulgar language in any manner at any time. NO PLAYER SHALL refuse to abide by an officials decision. NO PLAYER SHALL be guilty of objectionable demonstration of dissent at official's decision by throwing gloves, bats, balls, or other forceful action. NO PLAYER SHALL be guilty of using unnecessarily rough tactics in the playing of the game against the body or person of an opposing player or of any other type of unsportsmanlike conduct. NO PLAYER SHALL be guilty of personal abusive verbal attack on any player, official or spectator. NO PLAYER SHALL be guilty of physical attack as an aggressor upon any players, officials, or spectators. NO PLAYER SHALL smoke while going on or coming off the field of play, or in gym area. NO PLAYER OR FANS SHALL bring alcoholic beverages to the field or gym or any park premises. NO METAL CLEATS SHALL be permitted on the field. IF MANAGERS OR ACTING MANAGER IS EJECTED FROM THE GAME FOR ANY OF THE ABOVE, THE GAME SHALL BE DECLARED AN AUTOMATIC FORFEIT. Teams that forfeit more than one time will be disqualified from playing in the league.
