It is further understood and agreed that this wavier, release and assumption of risk are to be binding on my heirs and assigns. I agree to accept and abide by the rules and policies of the City of Huntington Park, Department of Parks & Recreation. This authorization shall remain in effect for all activities related to the above unless otherwise individuated or revoked in writing and delivered to said gent. The undersigned agrees that this Agreement, Release and Indemnity is intended to be as broad and inclusive as permitted by the laws of the State of California, and that if any portion of this document is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
