## Huntington Park Municipal Code Section 9-3.103(3)

A. Standards for Exterior Colors. Standards to paint a new building or re-paint an existing building shall be as follows:

- (1) The primary color of buildings shall be limited to an earthen hue background color, which is integral or applied consistently to the material. Colors include off-whites, siennas, light-grays, beiges, tans, browns or other similarly subdued tones, shades or colors as determined by the Director.
- (2) Special architectural features may use brighter colors as an accent. Colors shall complement the body color of the building, as well as highlight decorative details (e.g., as ornaments, trims, fascias, inlays, tile, ironwork, awnings and other architectural features), as determined by the Director.
- (3) Other elements on the building and property should be compatible and/or architecturally integrated with the color and design scheme of the primary building, (e.g., as roofs, fences and walls, signs, trash enclosures) and any other accessory structures or features.

**Acceptable background (as well as accent) colors include earth tone pale, pastel, light, subdued colors such as:**

beige	browns
off-white	siennas
tan	etc.

**Not acceptable background colors include bright or dark shade colors of:**

purple	green
orange	blue
yellow	or similar

**Accent colors should be complimentary and used for enhancing the overall color scheme. Bright and/or dark colors may be used for trim, tile, awnings, ornaments, and other architectural features.**
