

Minutes of the regular meeting of the City Council of the City of Huntington Park held Tuesday, January 22, 2008.

Following the Invocation by Pastor Reverend Ramon Camacho of Huntington Park's First Assembly of God and Pledge of Allegiance to the Flag, the meeting was called to order in the Council Chambers at 6:30 p.m. by Mayor Guerrero. Present: Council Member Ofelia Hernandez, Vice Mayor Mario Gomez, Council Member Juan R. Noguez, and Mayor Elba Guerrero. Absent: Council Member Elba Romo.

Mayor Guerrero and City Council presented a plaque to J.C. Penney in celebration of their 80th Year Anniversary in the City of Huntington Park.

John L. Glavinoch, MD, FACEP, displayed a PowerPoint presentation regarding Mission and Community Hospital Emergency Services and distributed copies of the presentation to City Council. Dennis Colman, CEO of Mission and Community Hospital, informed City Council that Mission and Community Hospital has undergone a series of surveys within the last year and has proven to be in good standing and requested the City's support in order to request State funding in the near future. Edward Rubin, MD/Owner of Mission and Community Hospital stated that his goal is to maintain health services at the hospitals and requested the City's support.

Mayor Guerrero opened oral communications, indicating that this was the time for anyone in the audience to address the City Council on any matter of City business.

Enrique Murillo, Health and Education Commissioner, thanked City Council for re-opening the Community Center and presented plaques to City Engineer Fu, Building Official

Lind, and Director of Field Services Poole. Mayor Guerrero presented Mr. Murillo with a City pin.

Andy Carrasco, Southern California Gas Company Public Affairs Manager, introduced himself to City Council and informed City Council that The Gas Company has programs available to the community that will help reduce their gas bill. Mr. Carrasco also informed City Council that he is active in the community.

Dante D'Eramo, Executive Director/CEO of The Greater Area Huntington Park Chamber of Commerce, invited everyone to attend the Annual State of the City Address at the Family Center at 3355 E. Gage Avenue on Thursday, January 31, 2008 at 7:30 a.m. Mr. D'Eramo also informed the City Council that the Chamber's Board of Directors appointed an Ad-Hoc Committee for Downtown Huntington Park Marketing Strategy.
