STAFF RESPONSE

City Attorney Araceli Almazan addressed the public comments related to Anthony Lowe. She stated that due to this being an active investigation the City and City Council are not in any position to comment on the facts regarding the ongoing investigation. She then clarified that the city upon receipt of a claim has a number of days to reject that claim and if it is not rejected within a very specific number of days it is deemed rejected by operation of law at which point council can file a lawsuit as it relates to the matter discussed during public comment.

Police Chief Lozano provided a response related the 58th Street alley. He shared that the police department continues to police that alley a minimum of three times per 24 hour period. When officers contact the individual's in the alley they are not involved in any criminal activity but police do clear the area because loitering is not permitted. Once officers leave the area the individuals return. He added that in addition to the patrols, police are also dispatched to the area when calls are received from residents. Then addressed the property line that has been marked off to identify private property. He stated that property owners should call police and report any intrusions onto private property. He then addressed the comment related how many patrol personnel. He stated that the Police Department does deploy an adequate amount of police personnel into the community. This includes patrol officers, parking enforcement, and public safety officers. He added that the Police Department also has an agreement with the Police Officers Union that mandate a certain number of officers be deployed per shift with varying ranks and specialized teams that work with and augment police presence in the community. He closed by sharing that the Police Department operates on a standing mutual aid agreement with neighboring departments and the Los Angeles County Sheriff's department that can deploy at a moments notice.
