27. has no power to bind the City Council or make decisions binding the City of
28. Huntington Park.

THE CITY COUNCIL OF THE CITY OF HUNTINGTON PARK DOES
RESOLVE AS FOLLOWS:

SECTION 1: Establishment of Committee and Purpose.

The City Council of the City of Huntington Park authorizes the establishment
of an Economic Development Committee to advise and report on economic
development matters.

SECTION 2: Membership.

The Economic Development Committee shall consist of the following three (3)
regular members: Graciela Ortiz, Karina Macias, and Efren Martinez and two (2)

1 alternate members from the City Council, First alternate shall be Jhonny Pineda and
2 the second alternate shall be Marilyn Sanabria. City Manager, Director of Community
3 Development, and Manager of Economic Development shall serve as supporting staff
4 to the committee. The Alternate member may participate in discussions of the
5 proceedings in the absence of one of the 2 regular members that are representatives
6 of the City Council. At no point shall there be more than 2 of the following members,
7 Ortiz, Macias, Pineda or Sanabria at the same meeting if and while all 3 concurrently
8 serve on the City Council.

9 **SECTION 3: Appointment, Reappointment and Removal.**

10 The City Council shall appoint all members of the committee. Committee
11 members may be removed by the Majority of the City Council. All appointments or
12 removal of Committee Members shall occur at an open meeting of the City Council.
13 If removal of a Committee Member occurs, the City Clerk shall send notice to that
14 Committee Member at the last address on file with the City.

15 **SECTION 4: Term of Office.**

16 Each Committee member's term shall be for a period of two years, unless
17 removed by the City Council.

18 **SECTION 6: Vacancy.**

19 If for any reason a vacancy occurs, it shall be filled by appointment by the
20 Council for the unexpired portion of such term.

21 **SECTION 7: Quorum.**

22 A majority of the total number of members of the Committee shall constitute a
23 quorum for the transaction of business, but a lesser number may adjourn from time
24 to time for want of quorum and until a quorum can be obtained.

25 **SECTION 8: Organization.**

26 The Chair of the Committee shall be appointed by the majority of the
27 committee. City staff shall act as the Committee Secretary. Staff liaisons shall act
28 as the conduit for all communications to the City Council.

SECTION 9: Meetings.

The Economic Development Committee shall meet at least once a month. A
majority of the four members shall constitute a quorum of the Committee. The place
of such meetings shall be at City Hall unless otherwise designated by the City Council
or approved by a majority.





CONSIDERATION AND APPROVAL OF A “LICENSE AGREEMENT FOR TEMPORARY FIRE STATION 164 BETWEEN THE CITY OF HUNTINGTON PARK AND THE CONSOLIDATED FIRE PROTECTION DISTRICT OF LOS ANGELES COUNTY” (LICENSE AGREEMENT)

IT IS RECOMMENDED THAT CITY COUNCIL:

1. Consider for approval a License Agreement for the placement of a temporary Fire Station 164 at Raul R. Perez Memorial Park (Park); and
2. Authorize the City Manager to negotiate final terms and execute the License Agreement.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

In the morning of May 1, 2024, a fire erupted at the existing location of Fire Station 164 on Santa Fe Avenue in the City. After a prompt response to the incident, the fire was quickly extinguished which resulted in structural damage to the building, but no injuries to any personnel.

In order to continue to provide proper fire protection services for the City, the Consolidated Fire Protection District of Los Angeles County (Los Angeles County Fire Department) has requested the use of the real property located at 6208 Alameda Street, commonly known as Raul R. Perez Memorial Park. If approved, this location would serve as a temporary Fire Station 164 while the permanent Fire Station 164 is being repaired. In addition to the community building located at the Park, the Los Angeles County Fire Department is requesting the use of the parking area and basketball court for fire apparatus and support vehicle parking.

Approving the License Agreement will be temporary and will also provide facilities to continue fire protection services in the same manner as currently being offered to the residents of Huntington Park.

The fiscal impact is minimal for any maintenance to be provided by the City for the temporary use of the community center as Temporary Fire Station 164. The County Fire will be responsible for all improvement(s) related to their use of the facilities for fire protection activities.

6 **THIS AGREEMENT** is made and entered into this _____ day of _____, 2024,
7 by and between the City of Huntington Park (CITY), hereinafter referred to as LICENSOR,
8 and the Consolidated Fire Protection District of Los Angeles County, hereinafter referred to
9 as "LICENSEE".

10 **WHEREAS**, LICENSOR is the owner of certain real property located at 6208 Alameda
11 Street, Huntington Park, CA 90255, commonly known as Raul R. Perez Memorial Park
12 (Assessor Identification Number 6321-008-902, 6321-008-906, 6321-008-907, 6321-008-908,
13 6321-008-909), and described in Exhibit A attached hereto and incorporated herein by
14 reference (hereinafter the "PROPERTY"); and

15 **WHEREAS**, LICENSEE provides fire protection and life safety services within the
16 CITY and desires to obtain permission to enter upon and use a portion of the PROPERTY to
17 facilitate the provision of such services; and

18 **WHEREAS**, LICENSOR has agreed to allow LICENSEE and LICENSEE has accepted
19 to utilize a portion of the PROPERTY to operate a temporary fire station; and

20 **WHEREAS**, LICENSEE is authorized to enter into this agreement by the Board of
21 Supervisors of the County of Los Angeles on August 14, 1984, to enter into property use
22 agreements with other agencies or entities where no compensation is involved.

23 **NOW, THEREFORE**, in consideration of these mutual covenants, the parties hereto
24 agree as follows:

25 **SECTION I - PROVISIONS**

26 1. LICENSOR hereby grants to LICENSEE a revocable license to enter and do the
27 following upon the PROPERTY:

28 a. LICENSEE may use a portion of the PROPERTY known as the Community

1 Building as Temporary Fire Station 164 (TEMP 164), as designated on Exhibit "A" attached
2 hereto and incorporated herein, for the purpose of providing fire protection and life safety
3 services. LICENSEE may also use the parking adjacent to the Community Building and one
4 basketball court for apparatus and personnel parking and bring other support vehicles upon
5 the PROPERTY for the purpose of providing and assisting emergency firefighting services.

6 b. LICENSEE may take and use water from taps and hydrants located upon the
7 PROPERTY and designated by LICENSOR.

8 2. LICENSEE shall not bring upon the PROPERTY, or use TEMP 164 to provide, any
9 hazardous or noxious chemical firefighting agent or other hazardous or noxious substance,
10 except fuels for immediate operation, without the prior written consent of the LICENSOR.

11 3. Access to the TEMP 164 under this Agreement shall be limited solely to
12 reasonably necessary employees and agents of LICENSEE participating in the provision of
13 services as contemplated herein this Agreement.

14 4. In lieu of commercial insurance coverage, LICENSEE shall self-fund any potential
15 liabilities arising out of or connected with this Agreement as set forth in Section IV of this
16 Agreement.

17 5. This Agreement may not be assigned.

18 6. This Agreement will remain in effect for 1 year and renewed annually or until
19 terminated by either party in accordance with Section III hereinbelow.

20 7. LICENSEE acknowledges that this Agreement grants only a temporary, revocable
21 license for limited use of TEMP 164 on the conditions set forth herein.

22 **SECTION II - REPAIR, MAINTENANCE AND UTILITIES**

23 1. LICENSOR, at its cost and expense, shall be responsible for all non-routine repairs,
24 hereinafter referred to as "major repairs", and shall be identified, in writing, by the LICENSEE.
25 LICENSEE shall be responsible for routine repairs including incidental plumbing and
26 electrical repairs, heating and air conditioner repairs, interior painting, and drywall repair.

27 2. Repair. Upon the discovery of any needed major repairs at TEMP 164, LICENSOR
28 shall be notified and provide a corrective action plan within thirty working days. Upon the

1 discovery of any emergency major repairs, LICENSOR shall be notified and provide
2 emergency repairs within **twenty working days**. Emergency major repairs shall be defined as
3 conditions that if left unrepaired would compromise the health, welfare, or security of the fire
4 station inhabitants or the public.

5 3. Grounds and Landscape Services. LICENSOR shall maintain and repair of
6 grounds and landscaping, including general landscaping maintenance, grass cutting, tree
7 maintenance, weed abatement, leaf collection, and litter collection, and other duties.

8 4. Locks, Keys and Access Authorization for TEMP 164. The lock style, types of
9 gates, and key/code authorization to be used at TEMP 164 will be coordinated in such a
10 manner as to allow access while maintaining the safety and property security of TEMP 164.

11 5. LICENSOR agrees to pay for the use of all existing gas, electricity, water, sewer,
12 telephone, and other utilities serving TEMP 164 or the improvements during the term of the
13 Agreement.

14 **6. All improvements shall be approved via the City's Building Department.**

15 **7. Facility must be returned or restored back to its original condition upon vacating the**
16 **lease to the satisfaction of the City.**

17 **SECTION III – IMPROVEMENTS**

18 1. LICENSEE improvements and alterations to TEMP 164 are listed on Exhibit B.

19 2. Any improvements related to LICENSEE's activities hereunder agreed upon by the
20 parties shall be installed at the LICENSEE's expense.

21 **SECTION IV - TERMINATION**

22 This Agreement may be terminated by either party at will upon sixty (60) days written
23 notice to the other party involved at the following addresses:

4 Upon termination, LICENSEE shall return TEMP 164 to its original condition.

5 **SECTION V - INDEMNIFICATION**

6 LICENSOR must indemnify, defend and hold harmless the LICENSEE, its Special
7 Districts, elected and appointed officers, employees, agents and volunteers ("County
8 Indemnitees") from and against any and all liability, including but not limited to demands,
9 claims, actions, fees, costs and expenses (including attorney and expert witness fees),
10 arising from and/or relating to the performance of this Agreement, except for such loss or
11 damage arising from the sole negligence or willful misconduct of the County Indemnitees.

12 LICENSEE must indemnify, defend and hold harmless the LICENSOR, its Special
13 Districts, elected and appointed officers, employees, agents and volunteers ("City
14 Indemnitees") from and against any and all liability, including but not limited to demands,
15 claims, actions, fees, costs and expenses (including attorney and expert witness fees),
16 arising from and/or relating to the performance of this Agreement, except for such loss or
17 damage arising from the sole negligence or willful misconduct of the City Indemnitees.

18 **SECTION VI - SEVERABILITY**

19 In the event that any provision herein contained is held to be invalid, void, or illegal by
20 any court of competent jurisdiction, the same shall be deemed severable from the remainder
21 of this Agreement and shall in no way affect, impair, or invalidate any other provision
22 contained herein. If any such provision shall be deemed invalid due to its scope or breadth,
23 such provision shall be deemed valid to the extent of the scope or breadth permitted by law.

24 **SECTION VII - WAIVER**

25 No breach of any provision hereof can be waived unless in writing. Waiver of any
26 one breach of any provision shall not be deemed to be a waiver of any breach of the

CONSIDERATION AND APPROVAL OF FIREWORKS SALES PERMIT APPLICATIONS SUBMITTED BY LOCAL NON-PROFIT ORGANIZATIONS IN THE CITY OF HUNTINGTON PARK

IT IS RECOMMENDED THAT CITY COUNCIL:

1. Approve the Fireworks Sales Permit Applications submitted by local non-profit organizations in the City of Huntington Park; and
2. Authorize the Community Development Department to process the applications and conduct the final inspections of the stands.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

Title 4, Chapter 8 of the Huntington Park Municipal Code provides the application process, procedures, and requirements for issuing fireworks sales permits. The chapter also details the safety requirements and operation standards for temporary fireworks stands. This section of the Municipal Code was amended to update requirements in order to identify the Community Development Department as the lead department for the application process, clarify applicant eligibility, and provide additional safety measures. Lastly, the amendment made the City Council the final approval body for the issuance of firework sales permits.

FACTS AND PROVISIONS

Applicants filed permit applications with the Community Development Department and their applications were processed for City Council review. The following organizations have submitted an application:

*Pursuant to previous practice, organizations that applied for Fireworks Sales Permit Applications had to maintain a good standing status with the City. Good standing includes possessing a valid and current non-profit status, having no open Code Enforcement cases, and providing any deliverables required by City Departments and/or Divisions. In this case, Praise Chapel does not have a Conditional Use Permit for their church use and must resubmit their project for review with the Planning Division.

The process to select the applications for City Council review included the eligibility review by requiring that permits be filed by local non-profit organizations only.

Additionally, applicants are aware of the increased public safety measures by requiring minimum ages for adults in charge of fireworks stand operations, requiring overnight security of stands, and updating sidewalk setback requirements in order to prevent obstruction of vehicular line of sight. It will also require Building and Safety inspections for the temporary stands.

The City Council is the final approval body for all complete fireworks sale permit applications.

Pursuant to Huntington Park Municipal Code 4-8.02, the sale of fireworks shall be limited to the time period of 12:00 noon on June 26th and ending at 11:59 p.m. July 4th of each calendar year.

Furthermore, Huntington Park Municipal Code 4-8.03 stipulates that complete applications will be presented to City Council at the first meeting in June for consideration.

FISCAL IMPACT

Fireworks sales permits will continue to generate required application fees including building permits, electrical permits, temporary use permits, and city business license fees. In addition, the permit fee for the sale of fireworks shall continue to be one percent of the gross retail sales as reported to the State of California Board of Equalization by the non-profit organization.

1. Make appointments to Commissions consistent with provisions set forth in Resolution No. 2015-19.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

On May 18, 2015, the City Council adopted Resolution No. 2015-19 which established a new process for making appointments to various City Commissions.

Individuals appointed to Commissions will be required to submit to a LiveScan and subsequently take an Oath of Office.

FISCAL IMPACT

RESOLUTION NO. 2015-19

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HUNTINGTON PARK ADOPTING REVISED RULES, METHOD OF APPOINTMENT, GUIDELINES FOR THE CONDUCT OF MEETINGS AND STRUCTURE FOR ALL COMMISSIONS OF THE CITY AND REPEALING ALL PRIOR RESOLUTIONS OR PROVISIONS IN CONFLICT WITH THE PROVISIONS CONTAINED HEREIN

WHEREAS, the City Council has decided to amend all commission resolutions to provide for congruent and consistent regulation and structure across all City Commissions.

THE CITY COUNCIL OF THE CITY OF HUNTINGTON PARK DOES RESOLVE AS FOLLOWS:

SECTION 1: Establishment of City Commissions.

The City has currently established the following commissions to serve in the capacity as advisory bodies to the City Council:

Planning Commission
Civil Service Commission
Parks and Recreation Commission
Health and Education Commission
Historic Preservation Commission
Youth Commission (pending approval).

This Resolution is intended to govern and supersede all prior resolutions establishing and amending member qualifications, organizational rules, guidelines and structure for City Commissions and hereby repeals all provisions in conflict with the provisions contained herein by the adoption of the revised provisions below. This Resolution will also govern over provisions of City ordinances currently in existence, but which will be repealed or amended for consistency with this Resolution. This Resolution shall also govern and control any additional Commission created by the City Council in addition to those enumerated above.

SECTION 2: Membership.

All City Commissions shall consist of five (5) members, with the exception of the Youth Commission which shall consist of ten (10) youth from the City as defined below. All members of each Commission shall be a resident of the City of Huntington Park, however, at the City Council's discretion, no more than two (2) Commissioners for any Commission may be non-Huntington Park residents. Each person seeking appointment to a Commission shall complete an application provided by the City and submit to a Live Scan background check before being appointed to a Commission and before being sworn in to office.

1 **SECTION 3: Appointment, Reappointment and Removal.**

2 Each member of the City Council shall have authority to appoint one (1)
3 member to each Commission, with the exception of the Youth Commission, which
4 shall consist of two (2) members appointed by each City Councilmember. Each
5 Councilmember shall appoint their Commissioners within sixty (60) days of assuming
6 office, or from the adoption of this Resolution, or from a vacancy occurring for said
7 Commission position for that respective Councilmember appointment. If no
appointment is made within sixty (60) days of assuming office, or from the adoption of
this Resolution, or from a vacancy occurring for said Commission position, the Mayor
shall appoint a member to the vacant seat.

8 Commission members may be removed from their appointment due to
9 disqualification as provided for in this Resolution or upon the sole decision by the
10 Councilmember who appointed that Commissioner. All appointments or removal of
11 Commissioners shall occur at an open meeting of the City Council. If removal of a
Commissioner occurs, the City Clerk shall send notice to that Commissioner at the last
address on file with the City.

12 **SECTION 4: Term of Office.**

13 Each Commissioner's term shall be for a period of four years, unless removed
14 by the appointing Councilmember or as a result of disqualification as set forth herein.
15 Notwithstanding the foregoing, no Commissioner shall serve for a period which
16 exceeds the time in office for the Councilmember appointing that Commissioner. In
17 the event that the appointing Councilmember completes his or her term, vacates their
18 office or otherwise is no longer holding office, the term of the Commissioner appointed
by said Councilmember shall end. However, nothing contained in this section shall
prevent another Councilmember or the new Councilmember from appointing the
individual back to the same Commission or to a different Commission.

19 **SECTION 5: Vacancy Due to Disqualification.**

20 When a member no longer meets the qualifications for the Commission, the
21 member is therefore disqualified, and the office shall thereupon become vacant.

22 **SECTION 6: Vacancy.**

23 If for any reason a vacancy occurs, it shall be filled by appointment by the
24 member of the City Council who appointed said Commissioner for the unexpired
portion of such term.

25 **SECTION 7: Quorum.**

26 A majority of the total number of members of the Commission shall constitute a
27 quorum for the transaction of business, but a lesser number may adjourn from time to
28 time for want of quorum and until a quorum can be obtained.

1 **SECTION 8: Purpose.**

2 The purpose, duties and responsibilities of each Commission shall be
3 established by the City Council by ordinance and codified in the Huntington Park
4 Municipal Code.

5 **SECTION 9: Organization.**

6 Annually in the month of March, the Commission shall elect one of its members
7 as Chair and Vice-Chair. City staff shall act as the Commission Secretary. Staff
liaisons shall act as the conduit for all communications to the City Council.

8 **SECTION 10: Meetings.**

9 Regular meetings of the Commission shall be as set by each Commission. The
10 place of such meetings shall be at City Hall unless otherwise designated by the City
11 Council or approved by a majority of the total membership of the Commission. When
12 the day for such regular meetings falls on a legal holiday, the meeting shall not be
13 held on such holiday, but shall be held at the same hour on the next succeeding day
14 thereafter which is not a holiday. All meetings of the Commission shall be open and
15 public, and subject to all laws of the state of California e.g. the Brown Act, governing
open public meetings. The Commission shall adopt its own rules for the transaction of
its business and keep a record of resolutions, findings and recommendations and
actions voted upon. A report of each meeting of the Commission shall be given to the
City Council.

16 **SECTION 11: Termination of Commission.**

17 Termination of the Commission shall be done at the will and vote of the City
18 Council.

19 **SECTION 12: Compensation.**

20 Commission member compensation shall be set by resolution of the City
21 Council.

22 **SECTION 13: Commission Handbook.**


23 All Commission Members must adhere to the provisions contained and
24 referenced in the City of Huntington Park Commission Handbook as approved by the
City Council.

26 The City Clerk shall certify to the adoption of this Resolution.


