1. 6336 COTTAGE STREET – REQUEST FOR PARKING T’S

RECOMMENDED THAT TRAFFIC AUTHORITY:

1. Restore Parking T’s on both sides of Cottage Street between Gage Avenue and Clarendon St. thereby maximizing the use of available parking spaces.

2. 6607 STATE STREET – REQUEST FOR RED TIPPING

RECOMMENDED THAT TRAFFIC AUTHORITY:

1. Reduce the available curb parking space to approx. 30' (on the south side) and 15.5' on the north side by painting the curb red 5' on each side of the driveway. Eliminate approx. 2' of existing red curb on the north side of the driveway.

3. 57TH STREET BETWEEN PACIFIC BLVD AND MILES AVENUE – REQUEST FOR PARKING SOLUTIONS

RECOMMENDED THAT TRAFFIC AUTHORITY:

1. Relocate the existing School bus drop-off/pick-up and parking from 57th St to 58th St in front of the school entrance to free up white curb areas and make the space available for public parking.
2. Re-stripe the existing faded Parking T's and extend Parking T's for the rest of 57th St from Pacific Bl to Miles Ave.
3. Install Parking signs for 2-4 hours of time-restricted parking.
