**1. RUGBY AVE AND RANDOLPH ST – REQUEST STOP SIGN**

RECOMMENDED THAT TRAFFIC AUTHORITY:

1. Approve the application to install an All-way Stop-control by installing Stop signs on the eastbound and westbound approached of Randolph Street at Rugby Avenue.

**2. 2863 ½ CLARENDON AVE – REQUEST FOR RED TIPPING**

RECOMMENDED THAT TRAFFIC AUTHORITY:

1. Reduce the available curb parking space to approx. 45' (on the north side) and prohibit parking on the south side by painting the curb red 5' on the north side and 14' on the south side of the driveway.

**3. HENRY T GAGE MIDDLE SCHOOL – REQUEST FOR TRAFFIC SAFETY MEASURES**

RECOMMENDED THAT TRAFFIC AUTHORITY:

1. Designate the Yellow Curb Area Adjacent to School Specifically for City Bus (HP Express) Loading/Unloading by Posting a Sign.
2. Provide Routine Enforcement for Citations to Prevent Illegal Parking at the Crosswalk for School Crossing.
3. Advise LAUSD to Install “School Drop-off/Pick-up” Signs at the Existing White Curb Areas adjacent to the school.
