

INTRODUCTION

At the special meeting of July 13, 2009 a recommendation was made to continue the budget review meeting to July 27, 2009.

ANALYSIS

A power point presentation was made showing the General fund estimated revenues and expenditures for fiscal year 2009-10. This preliminary analysis shows a deficit of \$2,284,931. Council would like to review each department's budget in more detail and recommended to continue the special meeting of July 13, 2009 to July 27, 2009. Present a schedule at the regular Council meeting of July 20, 2009 that will allow a half-hour review to each department. Some departments will be making power presentations of their individual budget.
