Dear Mayor and Members of the City Council:

APPROVE EXPENDITURES OF ART IN PUBLIC PLACES PROGRAM FUNDS AND ADDITIONAL BUDGET APPROPRIATION FOR PURCHASE OF TWO SETH THOMAS STREET CLOCKS TO BE INSTALLED ON PACIFIC BOULEVARD

#### IT IS RECOMMENDED THAT THE CITY COUNCIL:

- 1. Approve the Art in Public Places program funds expenditure for the purchase and installation of two Seth Thomas Street Clocks to be installed on Pacific Blvd; and
- 2. Authorize additional budget appropriation of \$190,719.56 to the Art in Public Places Fund Account # 232-8010-431.73-10, and
- 3. Authorize the Interim Finance Director to make the required payments vendors/contractors listed.

#### **BACKGROUND**

The Public Works Department manages the Pacific Boulevard Pedestrian Improvement and Pacific Boulevard Lighting and Beautification Improvement Project. This project was budgeted in FY 16/17 as a Capital Improvement Project. Art in Public Places program funds are available to utilize for the purchase and installation of two Seth Thomas Street Clocks. The clocks are to be installed in front of 6601 Pacific Boulevard (south/west corner of Zoe and Pacific), and in front of 6898 Pacific Boulevard (north/east corner of Saturn and Pacific).

#### FISCAL IMPACT/FINANCING

An additional budget appropriation of \$190,719.56 to account #232-8010-431.73-10 is requested at this time. The below table provides a breakdown of the total costs associated with purchasing and installation of the two Seth Thomas Street Clocks to be placed on Pacific Boulevard.
