- Untreated Wood & Small Branches
- NO Dirt or Rocks
- NO Pet Waste

Please place food waste in a plastic bag, tied securely, and place yard waste directly in bin.

- Fruits & Vegetables
- Meat, Fish, & Bones
- Coffee Filters & Coffee Grounds
- Grains & Legumes
- Food Scraps
- Dairy & Eggs

Bulky Items & Electronic Waste Pickups

For multifamily properties with more than 4 units, items such as refrigerators or chairs, that will not fit in your bin will require a special pick up. We will pick up bulky items or electronics with a limit of 4 items per pickup. Electronic waste includes electrically powered equipment such as TV and computer monitors, phones, radios, stereo equipment, and calculators.

Recycling Legislation

SB 1383 Effective January 2022

Short Lived Climate Pollutant Reduction Strategy

This bill requires:

- Organic waste collection services to all commercial businesses and residential properties.
- Food producers to donate excess edible food.
- Businesses will also need separate containers for organic waste and recyclables to be visible for their employees, customers, or tenants.

This law is implemented by your local jurisdiction and overseen by CalRecycle.

AB 341 Effective July 2012

Mandatory Commercial Recycling

Requires businesses and public facilities to enroll in recycling services and to recover as much waste as possible.

Holiday Schedule

Collection Service will not run on these holidays:

- New Year's Day
- Labor Day
- Memorial Day
- Thanksgiving Day
- Independence Day
- Christmas Day

If your regular collection day falls on or after one of these holidays, pick up will be delayed one day.

Why have an organic waste bin?

Landfills are responsible for 30% of California's green house gas emissions. When organic waste goes to a landfill, it is forced to decompose without oxygen, creating methane gas.

To reduce this percentage California passed (SB) 1383 which requires businesses and residential properties to enroll in organic waste recycling. This bill will also require businesses to donate excess edible food to a food bank or non-profit.
