

**NOTICE OF PUBLIC HEARING, 30-DAY REVIEW PERIOD
AND COMMUNITY MEETINGS FOR THE CITY OF HUNTINGTON PARK
FY 2022-2023 ONE-YEAR ACTION PLAN**

NOTICE IS HEREBY GIVEN that the City of Huntington Park’s scheduled public hearing at 6:00 p.m. on July 19, 2022, will be held before the City Council for approval in the Council Chambers located at 6550 Miles Avenue, Huntington Park, California 90255. The hearing serves as a means for eliciting the views and opinions of Huntington Park residents regarding the City’s community development and housing needs.

The City will conduct two (2) public meetings on the following dates:

Wednesday, June 22, 2022 2:30pm- 3:30pm

The purpose of the Community Meetings is to open a dialogue and solicit comments from the residents as to the current needs of the community for potential inclusion into the City’s One-Year 2022-2023 Annual Action Plan. Comments provided during the Community Meetings and public hearing will be considered during the preparation of the City’s One-Year 2022-2023 Annual Action Plan, which is a document that combines the planning and application aspects of the four formula HUD programs, including the Community Development Block Grant (CDBG) and HOME Investment Partnerships (HOME) programs. The public hearing also serves to assess whether changes in perception of community development and housing needs or implementing projects have occurred since the adoption of the City’s Five-Year Consolidated Plan for Fiscal Years 2020/21 through 2024/25.

The Consolidated Plan includes an assessment of housing and community development needs and priority non-housing needs. The Consolidated Plan functions as a strategic plan prepared through a comprehensive planning process that incorporates local needs, priorities, specific objectives and strategies. The Consolidated Plan furthers HUD’s statutory goals of providing decent housing, a suitable living environment and expanding economic opportunities through a collaborative process whereby a community establishes a unified vision for community development actions. The Action Plan will program CDBG and HOME funds to specific activities for the 2022-2023 program year spanning from July 1, 2022 through June 30, 2023. For the One-Year 2022-2023 Action Plan, the City will be receiving approximately a total of \$1,112,249 in CDBG funds and \$640,934 in HOME funds to implement activities that benefit low- and moderate-income residents.
